Fenner Laughinghouse Sr., is Dead: The city was saddened Christmas morning by the annoucement of the death at 6 a.m., of Mr.Fenner Laughinghouse, Sr., one of the city's most respected and honored useful citizen. Deceased had enjoyed good health up to the day prior to his death, when he fell, while fixing a Christmas tree for his grandchildren. Though complaining of bruises, his condition was not thought alarming, at that time. Death is attributed to heart trouble, intestified by the fall. Funeral services will be held Friday morning at the Mt.Vernon cemetery, conducted by Rev.J.H.O'Bryant, with the following as pall bearers: Active, R.H.Payne, A.C.Bridewell, A.B.Nimocks, J.E.Ferguson, R.C.Eldridge, and C.L.Simmons. Honorary: J.D.Baugh, E.A.Rolfe, and W.F.Perkins. Deceased is survived by his widow, Mrs. Elouise m.Mallory Laughinghouse, and the following children, J.Fenner Jr., Mrs.Louise m.Laughinghouse (Fred) Jones, Mrs. Marguerite m.Laughinghouse (J. Cornelius.) McCurdy, two sisters, Mrs. Mary Winnifred m.Laughinghouse (John Edward) Eldridge, and Miss Anna Laughinghouse (1856-1947), and several grand children. Dec.2, 1918 of last year was the golden wedding anniversary, m.1868. Deceased was born in Alabama in 1846, but came to Arkansas in 1858, and has resided here continuously from that date. He has held many positions of honor and trust, among them Clerk of the Court. At the time of his death, he was the chief accountant for the firm Brandon & Baugh. When Mr.Laughinghouse came to Arkansas, the only railroad was the short line from Memphis to Madison.

The Forrest City Motor Company has a long history in Forrest City, as successor to the original firm, the Mallory-Eldridge Livery Stable, partners were Mr.G.B.Mallory and Rolfe Eldridge Sr., before automobiles came about. and was founded on Oct.1,1906.

Mr.Eldridge had returned to Forrest City after working several years as a construction lineman for the Western Union Telegraph Co. in eastern states. He was born in 1880, the son of Mr.& Mrs.J.E.Eldridge on the old Eldridge farm north of Forrest City. He graduated from Forrest City High School. In 1912, Mr.Josh Mallory died in 1912 and Mr.Eldridge had other partners, Rufus Scott, Bert Mallory, and J.W.Aven, before his son in law, Rodgers Deaderick purchased an interest. In 1916, the firm went by the name Forrest City Motor Company and sold the Gardner, Overland and other makes before acquiring the Chevrolet franchise. In 1918, they added the Studebaker dealership, but retained it only a few years. In 1947 they obtained the Oldsmobile franchise. In 1931, his son in law joined the firm. Mr.Eldridge married Miss Corrine Ritchie of Augusta on May 13,1910, and to that union wears born three sons, and two daughters. His daughter Carrelyn, married Mr.Rodgers Deaderick. His other daughter, Margaret, is the wife of Col.W.P.Wilson, Jr. of the National Guard Air Force in Washington, D.C. Mr.Rolfe's three sons are Rolfe Jr., engineer for the Vaccaro-Grobmyer Lumber Co here; John E., physician in pediatrics in San Francisco; and Paul Ritchie, an active partner in the motor company. Mr.Rolfe has been a member of the Odd Fellows and Woodmen of the World, a member of the Methodist church for 43 years, and a member of the Forrest City School Board for six years. With his 33 years experience, specializing in roses, he was born in Appleton, Wisconsin, attended Appleton schools, and was a bank clerk for seven and a half years before moving to Forrest City in 1914 to join his brother in the Forrest City Box Factory as Asst.Superintendent. In 1917, he married Miss Mae Laughinghouse, daughter of the late Mr.& Mrs.Neuman Laughinghouse, members of pioneer families of this section. It was their land that was sold to build the Beech Grove addition after World War II. The Seatons have five sons, and one daughter-Fred Jr. is Chief Precision Inspector for Flexonics, Inc., Memphis. Billy is a florist in West Memphis; Mary Virginia is Mrs.C.Harbin Jr., of Memphis; Robert is farming near West Memphis; Dick is a machinist and layout man for Bauer-Woods Machine Co. in West Memphis; and Bert attends the Forrest City High School, and is circulation manager for the Daily Times-Herald. [Willie Alicia Raiford Laughinghouse-Born:Feb.27,1866 Died:Mar.18,1925] Mrs. Willie Alicia Laughinghouse died at the Baptist hospital in Memphis at midnight, Wednesday night, Mar.18,1925, of meningitus, contracted following an operation for mastoids a few days ago. The body will arrive in Forrest City on the California Special this afternoon, and funeral services will be held sometime Friday. Mrs.Laughinghouse was the daughter of Mr. Philip T. Raiford (Raeford on Willie's death Certificate) (1838 Alabama-1902). On Dec.23,1887, she was united in marriage with Mr.Neuman Laughinghouse who preceded her in death 12 years ago. To their union were born three children, two of whom, Mrs.Fred Seaton of this city, and Lieutenant Neuman Laughinghouse, survive. Lt. Laughinghouse is stationed in Manilla, the Phillipines Islands, in the aviation division of the U.S.Army. Deceased is also survived by a sister, Mrs. Elma m.Raiford (Ike) Mallory, and a half brother, Matthew Raiford of Memphis. A particularly sad feature of the case is that her sister, Mrs.Mallory, is also in the Baptist hospital for a similar operation, and will be unable to attend the funeral. Mrs.Laughinghouse was a devoted member of the Methodist church, and was loved and admired by a large host of friends in the City and County, who mourn with the bereaved family in their loss.
